**The terms and conditions of this agreement**

All pre-buy minimums are to be sold. No refunds will be given on unsold pre-buy tickets. If the pre-buy adult minimum is not met, the company will still be responsible for payment on consignment tickets sold.
2. Company agrees to remit payment of \$ \_\_\_\_\_ by \_\_\_\_\_. This payment is to be made in the form of CHECK or CREDIT CARD (no cash), made payable to Kansas City Renaissance Festival and forwarded to the attention of Group Sales Department, 628 N. 126th Street, Bonner Springs, KS 66012.
3. Company assumes full responsibility and agrees to pay Mid-America Festivals for all unreturned tickets, regardless of the reason for said non-return, including, but not limited to those tickets lost or stolen. All purchases by employees, members or patrons are nonrefundable.
4. Should the supply of tickets consigned be depleted, additional consignment tickets may be requested at the above contracted rate. Please allow 3-5 days for delivery.
5. Company agrees to make a final accounting of all monies and purchased tickets by October 28th, 2016. All money due and any unsold tickets above the pre-buy minimum will be returned to Kansas City Renaissance Festival by Certified Mail, United Parcel Service (UPS) or our return package. Any tickets not returned by October 28th, 2016 will be considered sold and the Company agrees to pay full value of the tickets consigned or purchased.
6. Once the Pre-Buy Ticket Sales Agreement is signed, the price and quantity of tickets ordered and minimum number of tickets to be sold is firm. Any surcharge or change in the above selling price must be requested in writing by the Company. Price may change only upon written approval of authorized Kansas City Renaissance Festival representative whose signature appears below.
7. The Pre-Buy Ticket Sales Agreement is for the express use of Company employees, members or patrons.
8. Signature indicated acceptance of the proceeding agreement and authority to enter into the contract.
