THE TERMS AND CONDITIONS OF THIS AGREEMENT

1. **Term:** This agreement will commence upon the acceptance date and will continue throughout the 2023 season. This agreement may be terminated prior to the end of the season if the Festival cancels the agreement because Organization fails to follow provisions of this agreement.
2. **Online Access Code:** Festival will provide Organization with a "Government/Service Online Discount Code" that will allow employees to access discounted tickets from the Festival's website.
3. **Eligible Purchasers:** Organization agrees to limit access to the Online Code to employees and qualified contractors at Organization.
4. **Promotion:** Organization agrees to promote the program to eligible employees throughout the season through appropriate company communication channels, such as email, posting signs in employees' common spaces and/or listing on an internal website. Festival can provide promotional materials upon request.
5. **Employee Compliance with Terms:** Anytime the Online Code is given to employees, Organization agrees to communicate to eligible employees that they must comply with this agreement, specifically to not share the Online Code with non-employees or post the code in an area where they know it can be seen (such as a public website, email broadcast, or written document, etc.)
6. **Changing Online Code:** Festival reserves the right to change the Online Code at any time. Organization agrees to notify employees of any Online Code or program changes.
7. **Reconciliation:** Organization will not be required to make payments to Festival. Each employee purchase will be paid online. The Festival can provide Organization with sales numbers for its Online Code upon request.
